My name is Vanessa Carasa and I live in Meredith Parkwood. I am in **opposition** of May 26th hearing regarding the proposed gas station on Tustin and Santa Clara. Unfortunately, due to the Covid-19 pandemic I was not aware that this proposal was being discussed. I have lived in the neighborhood for 10 years and my children are alumni of Plumfield Preschool next to the proposed gas station.

A gas station next to 2-5 years olds is not healthy nor safe. The children play outside and have class instruction outside often. To have such little children be exposed to the fumes of gasoline is irresponsible and dangerous! Inhalation of gases are especially harmful to children with growing lungs.

In addition, traffic, adjacent to, children being dropped off can pose a safety risk. Loud cars, coming in and out all day can also be a major distraction to learning minds.

I know many people in this neighbor have used, or still use, Plumfield as the first learning academy for their children. It would be very unfortunate for such a great business be jeopardized.
