Why Transit-Supportive Zoning? □ All good plans for urban renewal include four elements: (1) mixed use development, (2) open space and parks, (3) a strong pedestrian environment that is supported by alternative access -- i.e., effective transit, and (4) affordable housing □ Areas that achieve the above reduce vehicle travel by nearly 50 percent □ Developers within such areas are more committed to implementing the cities' plans □ Greenhouse gas emission reductions are significantly reduced □ Public health is improved (people walk more, air quality improves) □ Businesses thrive (people live, work, dine and shop in the same area) □ Adopting Transit-Supportive Zoning will help our Fixed Guideway project better compete for funding: □ By increasing ridership projections
