Project Location: 1702 North Main Street located in the Community Commercial Museum District

(C1-MD) zoning district.

**Project Applicant:** Leslie Gentile, representing Farmers & Merchants Bank

<u>Proposed Project:</u> The applicant is proposing to demolish an existing commercial building and construct a new multi-tenant building for Farmers & Merchants Bank and a second future tenant. The project will feature an 8-foot setback for the front and side yard and landscape areas. In order to facilitate construction of the project, the applicant is requesting approval of Variance No. 2020-01 to allow a reduction of 7 feet from the City's setback standards of 15 feet for front and side yard and landscape areas.

<u>Environmental Impact:</u> The Planning Commission will consider a determination that the project is categorically exempt from the California Environmental Quality Act (CEQA) pursuant to Section 15303 – Class 3 – New Construction.
