Hello Rose Ann -

As part of the Empowerment Zone grant close-out process, the City Attorney's office and I have been working closely with HUD in developing the attached covenant document which upon execution will be recorded with the County Clerk-Recorder. HUD is requiring that a covenant be filed on the property to ensure that the land acquired by use of federal dollars is used as a teen and youth center per the original intent as awarded by the SAEC. Below is the link to the June 23, 2004 SAEC Board meeting minutes showing the action taken. Should the use change or there is an effort to sell the property during the term of the covenant the Club will be required to seek direction from the City and HUD on repayment of the \$463,958.62. The covenant is scheduled to expire 10 years from the recording date.

The Executive Director of the Club has signed the document as well as Lisa Storck from the City Attorney's office and now is ready for the City Manager's notarized signature. If at all possible I'd like to have the document signed ASAP.

DECLARATION OF COVENANTS AND

RESTRICTIONS OF BOYS & GIRLS CLUB OF

SANTA ANA TEEN CENTER

(950 W. Highland Street, Santa Ana, CA 92703)

THIS DECLARATION OF COVENANTS AND RESTRICTIONS OF BOYS & GIRLS CLUB OF SANTA ANA TEEN CENTER (the "Restrictions") are entered into as of the 23 day of September, 2014, by and among The Boys and Girls Club of Santa Ana, a California a California non-profit corporation (referred to herein as the "Grantee") and the City of Santa Ana, a charter city and municipal corporation (hereinafter "City").

RECITALS:

- A. Grantee is the owner of certain real property commonly known as 950 W. Highland Street in the City of Santa Ana, County of Orange, California, which is more particularly described in Exhibit 1, attached hereto and incorporated herein by reference ("Property").
- B. The City's former Empowerment Corporation gave Grantee a Federal Department of Housing and Urban Development ("HUD") Empowerment Grant in the amount of \$463,958.62 ("Empowerment Grant") for the acquisition of the Property located at 938 W. Highland Street to merge with property already owned by Grantee for purposes of constructing and operating a teen and youth center to undertake programs for public education, recreation, and health, which will serve the youth and teens within the Empowerment Zone designated by HUD for the area surrounding the Property ("Empowerment Zone").

NOW THEREFORE, for good and valuable consideration the parties agree as follows:

1. Grantee hereby declares that the use of the Property shall be for a teen center to undertake programs for the youth centered around public education, recreation, and health; or for any other eligible Empowerment Zone activity, including but not limited to programs geared toward educating, training and providing services to the Empowerment Zone neighborhood and business communities (individually or collectively, the "Program") for a period of ten (10) years after the date of these recorded Restrictions (the "Term").

- 2. In the event the Grantee ceases to operate the Program, Grantee shall be required to reimburse City and/or HUD, in full or a portion of the Empowerment Zone grant used to purchase the Property, based on direction from HUD at such time, and this Declaration of Covenants and Restrictions shall immediately become null and void.
- 3. Upon expiration of the Term or, if applicable, reimbursement to City and/or HUD by Grantee, these Restrictions shall immediately become null and void and an appropriate release and termination of these Restrictions shall be recorded in the public records.
- 4. HUD and the City shall have the right, but shall not be obligated, to proceed at law or in equity to compel Grantee to comply with the terms hereof or to prevent the violation or breach hereof. In the event of a dispute under these Restrictions, the prevailing party shall be entitled to its reasonable attorneys' fees to be paid by the losing party as fixed by the court.

IN WITNESS WHEREOF, the Parties have executed this Declaration of Covenants and Restrictions as of the date first written above.




